		These paragraphs are as follows:
		Subject to the "public interest" test, information relating to:
		 Para 1 – <u>any individual;</u>
		• Para 2 – the identity of any individual;
		 Para 3 – <u>financial or business affairs;</u>
		 Para 4 – <u>labour relations matters;</u>
		Para 5 – <u>legal professional privilege;</u>
		• Para 6 – <u>a notice, order or direction;</u>
		• Para 7 – the prevention, investigation or
		prosecution of crime;
		and may need to be considered as 'exempt'.
