Bromsgrove Planning Committee Outcome

Following the publication of the committee report, the 24/00077/REM application was granted, subject to conditions, at Bromsgrove DC Planning Committee on 9th July.

Affordable Housing

This section could be read in conjunction with the affordable housing section of the main report and is to assist members in relation to affordable housing across the hybrid permission (Phases 3,4,5, and 6). It outlines that the applicant has complied with Policy 6 Affordable Housing when taking a holistic view of the four phases together.

Notes:

Phase 1 was determined under a previous version of the Borough of Redditch Local Plan (No.3) which required a higher percentage of affordable housing of 40% instead of the current level of 30%. Phase 1 included 14 dwellings approved under 2010/008/FUL (14 dwellings, open space and access road Granted 21st April 2010) on top of the 171 approved to ensure a policy compliant provision of 40%.
