5. Exclusion of the Public

These paragraphs are as follows:

- Para 1 any individual;
- Para 2 the identity of any individual;
- Para 3 financial or business affairs;
- Para 4 <u>labour relations matters</u>;
- Para 5 legal professional privilege;
- Para 6 <u>a notice, order or direction;</u>
- Para 7 the <u>prevention</u>, investigation or prosecution of crime;
