PUBLIC SPEAKING

The Council has introduced public speaking at Licensing Committee which allows members of the public to comment on agenda items due to be considered at the meeting. The usual process for public speaking at meetings of Licensing Committee will continue to be followed for virtual meetings with public speakers being invited to participate in the Skype meeting.

The total maximum time permitted for public speaking is 15 minutes and the time limit for individual speakers is 3 minutes per speaker.

Only those members of the public who have registered to speak in advance of the meeting will be permitted to do so.
