The chair is appointed by the Board but the deputy is elected from the Labour members of the committee. The Mayor is a conservative. As this was the first meeting of the new municipal year only a few of us moved and accepted the minutes of the last meeting. The Chair took the opportunity to thank the retired members.

We had a report on the 'trailblazer' devolution deal in which both WMCA and Manchester are fast tracking the next deal with the Government, transport, skills and housing being the main areas of interest. The WMCA need to have the submission ready for September 2022.

Following this was a more detailed report on the 'levelling up' provisions. There are a range of specifications some of which apply to local authorities, the most important one being planning.

A verbal report on O&S governance was given after questions were asked at the previous meeting. It appears that O&S members are considered to be co-opted and as such can have an allowance. It was also explained that reports should be either 4 or 6 pages maximum, depending on the context. The Transport Security Sub-Committee is an anomaly being set up under a previous system but is hoped to bring it into line with the WMCA.

The allocation of the Skills budget was discussed at length with Birmingham having 50.68%. Employment is returning to pre-covid levels and there are more level 3 qualifications but still not enough. It was suggested that there was a need for more lower-level qualifications to fit the job market.

Finally the committee had a view of the grant register and was able to comment.

As is usual, the pre-meeting discussed the various questions and a range of general comments were made as to the general state of the NHS in Worcestershire.

The Worcestershire Acute Hospitals NHS Trust (the Trust) introduced the Integrated Care System that was a combination of the board and providers. It is anticipated that this will break down barriers and give better outcomes. Several explanations were given about current health care, which is expected to improve in 5/6 weeks. One area of concern is the ambulance hand over time particularly at the Royal Worcester Hospital. An acknowledgement was given that there is "always room for improvement."

One other area that was discussed was the arrangements for discharge from hospital. Golden Discharge was still not in place although discharge timing was improving.

The hospitals were back into using a significant amount of personal protective equipment (PPE), with staff being off for 5 days after a positive covid test.

A new bed system is in place which everyone tries to allow a quicker admission to discharge. This is expected to be the "Right Plan."

When questioned on minor Injury Units the response was that they are all different, with opening times and availability detailed on the respective websites. The chair is pushing for improvement all-round by September 2022 and HOSC are expecting quality reports showing where the improvements are.

Covid vaccinations in Hereford and Worcestershire are going well but we still have a high percentage of the young and areas of deprivation where the numbers are low. Mortality rates are below national averages.

The massive survey held between February and May 2022 is helping to develop a 10-year strategy. Action plans are being prepared for many areas particularly alcohol and drug abuse. It is expected that these will come to HOSC as early as September.

The budget of £30.365M is allocated with a reserve of £9.7M most of which is also allocated to projects.
