### 1. APOLOGIES FOR ABSENCE AND NAMED SUBSTITUTES

There were no apologies for absence.

#### 2. DECLARATIONS OF INTEREST

#### 3. MINUTES OF THE LAST MEETING

#### **RESOLVED** that

The minutes of the meeting of the Electoral Matters Committee held on 29<sup>th</sup> February 2024 be approved as a true and accurate record and signed by the Chair.

#### 4. POLLING PLACE CHANGES FOR PARLIAMENTARY ELECTION ON 4TH JULY 2024

The Committee considered a report recommending polling place changes for the Parliamentary election on 4<sup>th</sup> July.

Poll cards were being sent out to the majority of electors in the next few days. Due to the short notice for the election, there were two polling station venues which were not available on this occasion. Potential alternative venues had been suggested and details were provided for the Committee.

Polling District WID – the current polling station, Lavender Barn at the Old Rectory House, was not available for the election. It was

proposed this should now be at St Peter's Church Hall in Ipsley. Officers reported that this could accommodate a polling station and was a suitable site, although slightly further away for electors to visit than Lavender Barn. A ward member had told the Elections team they were happy for the change subject to accessibility being confirmed, which it had.

Polling District NRA – the current polling station was the Abbey Hotel, which was unavailable. A number of potential alternative venues had been considered but were not suitable for the election because of access issues or size constraints. Officers suggested that the Meadow Farm Hotel would be the most appropriate alternative as a meeting room could be used with a small parking area adjacent to the venue.

Officers reported that the (Acting) Returning Officer supported the use of both venues for polling stations.

The Electoral Services Manager reported that in the short term there was a risk of a polling station no longer being available for the General Election, so officers had suggested a delegation to enable the Acting Returning Officer to alter venues, having consulted with the Portfolio Holder and Ward Members. The delegation would apply to this General Election only. A member suggested that in addition to the Portfolio Holder and Ward Members all members of the Committee should be consulted as they had a view of arrangements across the Borough, and this was agreed.

It was noted that the Committee would be asked to review polling places later in the year, both for local reasons and potentially as a result of the review of county council electoral divisions. Recommendations from this were due to be released by the Local Government Boundary Commission for England in early July.

Members spoke in support of the alternative venues proposed for Polling Districts WID and NRA.

#### **Operational Implications**

- 6.2 The first two polling places to be considered, which were used in both the May and July elections, have received a request to be reviewed.
- 6.3 The Red Lion Public House, Hunt End

The venue was used for the first time in May and again in July. It replaced the Portable Building in Banners Lane that was used previously.

The actual polling station is in a marquee at the rear of the public house so electors either enter it via the pub itself or from the car park at the rear.

The electorate for the UKPGE was 1,605 and the Presiding Officer at both elections had several complaints about the uneven car park.

At the May elections there had been issues regarding signage but these were rectified for July.

The Equalities Inspector and the Polling Station Inspector both raised concerns about the car park. The Equalities Inspector also raised issues regarding lighting and heating especially if this were to be used as a polling station in Winter.

Neither officer recommended using it as polling station in the future.

The problem going forward is lack of suitable buildings in the area.

The only other option seems to be reverting back to the Portable Building in Banners Lane which is also not accessible and has a higher cost.

#### 6.4 Portable Building, Atworth Close

The venue was used for the first time in May and again in July. Previously electors went to vote at Woodrow Community Centre but now the 671 electors of polling district HOD – Wirehill are now in a different borough ward so a portable building on Atworth Close was decided to be the best option for polling.

The portable building was sited near the entrance to Atworth Close on a strip of grassy land. At the May elections there was a problem with siting the building due to parked cars.

Another issue is that due to the grass a complex ramp needs to be erected each time the station is used.

Some residents of Atworth Close raised concerns at the siting of the portable building and wished for this to be reviewed post election.

The Equalities Inspector did note that there is only on street parking but also noted that a portable building was the only option for this area due to the lack of community facilities.

It should be noted that officers and previous members of this Committee spent a considerable amount of time in the past looking for alternatives to this site.

It seems that the only other feasible option would be to move electors to the polling station on Grangers Lane; although this would mean additional travel for those electors in Wirehill. If this option were

chosen it would make sense to combine polling districts HOC and HOD.

Members of this Committee may wish to consult with the electors of polling district HOD regarding their preference and bring this back to a future meeting of this Committee.

6.5 The next two polling places were used at the UKPGE in July as the previous polling places were not available.

#### 6.6 Farmhouse Meeting Room, Meadow Farm Hotel

This venue was used as the Abbey Hotel was unavailable on 4 July. The Abbey Hotel had only been used as polling place once before; that was in the May 2024 elections.

It serves a small electorate of 308 and no complaints were received regarding using the Farmhouse Meeting Room.

There were no adverse comments from the Equalities Inspector and positive comments received from the Presiding Officer, both would recommend using this venue again.

The Polling Station Inspector made the additional comment that there could be a need for additional signage.

Costs were considerably less for using the Farmhouse meeting room compared to the Abbey Hotel.

Officers would recommend using the Farmhouse Meeting Room in future.

#### 6.7 St Peter's Church Centre, Ipsley

This venue was used as the Lavender Barn at Old Rectory House was unavailable on 4 July. The Lavender Barn had only been used as polling place once before in the May 2024 elections.

The electorate at the UKPGE was 929 and no complaints or adverse comments were received.

The Equalities Inspector and polling station inspector noted small issues with path but that it was still accessible for votes. It was recommended that it be retained as polling station.

The Church Centre costs more than the Lavendar Barn but officers would recommend it's continued use because of it being more flexible in its availability at short notice.

### 7. <u>RISK MANAGEMENT</u>

- 7.1 Any changes agreed must be likely to be sustainable for a reasonable number of years, as frequent changes of Polling Station are not helpful for electors and undermine their knowledge of, and confidence in, electoral systems.
- 7.2 Choice of Polling Place / Polling Station should not give rise to significant grounds of complaint which might put election results at risk of challenge.

- 6.2 The LGBCE published the Final Recommendations for the new electoral county divisions in Worcestershire on 9 July 2024 and a draft order was laid before Parliament on 11 September 2024.
- 6.3 Details of the review can be found on the LGBCE website:. <u>LGBCE</u> <u>Review Details - website link</u>
- 6.4 For the Redditch Borough area the LGBCE recommended four divisions, all of which will have two members.
- 6.5 During the consultation on draft recommendations there were two proposed divisional boundaries where the Committee submitted changes on behalf of the Council (minute 17 of 29 February 2024 meeting of this Committee).
- 6.6 The changes were rejected by the LGBCE which means some polling districts and polling places need to be reviewed.

#### 6.7 Redditch West Division

The request from the Committee rejected by LGBCE was that area covered by the current polling district WCD2 (appendix 1) be included in Redditch South Division.

The polling district is currently made up of 27 electors living in Lower Grinsty Lane and vote at the Gazebo at Callow Hill. As these electors will be in Redditch West Division an extra polling station would be required. The Gazebo would not be able to accommodate this and would not make economic sense to have an extra station for 27 electors.

As it is not suitable to use the Gazebo, due to its size, it is recommended that the polling district WCD2 becomes part of polling district WCB and the electors vote at Webheath Village Hall.

It should be noted that there is no change to Borough Warding.

#### 6.8 Redditch Central & East Divisions

The request of moving polling districts NRC/NRC2 wholly into the Redditch East Division and polling districts NRB/NRB2 wholly into Redditch Central Division was rejected by the LGBCE.

The map in appendix 2 shows the divisional boundary currently running down Papermill Drive (blue line on map) and that the new divisional boundary will run north to south along Tanhouse Lane before travelling

east along Church Hill Way until in joins Papermill Drive (red line on map).

This means a number of changes shown in appendix 2 are required to the polling districts within the two divisions and within the North Borough Ward. It should be noted there are no changes to the borough ward and the changes of polling districts are for administrative purposes.

Officers have studied the areas and as polling districts cannot cross boundaries suggest the following:

- The current NRB/NRB2 polling districts become
  - NRB which covers properties north of Church Hill Way and west of Ridings Lane, Bomford Hill Park, Wharrad Close and Upper Field Close. These will be in Redditch Central Division.
  - NRD which covers properties south of Church Hill Way. These will be in Redditch East Division.
- The current NRC/NRC2 polling districts become
  - NRC which covers properties north of Church Hill Way and west of Tanhouse Lane to the new boundary of NRB as described above. These will be in Redditch Central Division
  - NRE which covers properties east of, including, Tanhouse Lane and north of Church Hill Way. This will be in Redditch East Division.
- There are no actual changes to current polling district NRD other than to change the polling district letters to NRF.
- Electors will still go to their existing polling stations so will not notice a change.
- Officers suggest the following names for the polling districts although Members may be better placed to suggest alternatives:
  - NRB Papermill
  - NRC Church Hill North
  - NRD Sevenacres
  - NRE Abbeywood

### 7. <u>RISK MANAGEMENT</u>


