- Para 3 <u>financial or business affairs</u>;
- Para 4 <u>labour relations matters</u>;
- Para 5 <u>legal professional privilege</u>;
- Para 6 a notice, order or direction;
- Para 7 the <u>prevention</u>, investigation or <u>prosecution</u> of <u>crime</u>;
 and may need to be considered as 'exempt'.
