PROPOSED NEW DWELLING AND GARAGE IN THE GARDEN

FIELDHOUSE, FECKENHAM ROAD, HUNT END, REDDITCH, WORCESTERSHIRE, B97 5QP

The Agent has submitted an amended Location Plan & Site Plan on 17.09.13 showing the additional Willow tree to be removed from the site plan (marked with a red note and arrow). The applicant has confirmed by e-mail that the Willow tree, just north of the proposed entrance, has died according to a tree surgeon (who is pricing the removal of the trees by the bridge) and therefore the trees will have no adverse impact on the visibility safety for vehicles exiting the site.

The Applicant has confirmed by e-mail that he wishes to make a statement to the Committee to review the Design & Access Statement submitted by the agent whereby the intended specification has been amended to include Oakwright's highest specification wall and roof encapsulation system which would allow the new dwelling to achieve near 'passive energy' standards. The enhanced specification panels, similar in construction to the ones originally envisaged, would achieve higher insulation levels by increased thickness. However, the overall footprint of the design would be maintained by eliminating any brickwork other than that below dpc (i.e. the additional insulation thickness is similar to the additional width of a brickwork course compared to render or weatherboard). Therefore, the elevations would consist of a combination of render and weatherboard with practically no facing brickwork. The amended specification would improve the energy efficiency of the dwelling to 'state of the art'.
