Redditch Borough Council is considering **removing** the following requirement from its policy on the licensing of **hackney carriage and private hire drivers**:

"With effect from 1st December 2017, holders of driver licences must pass a Driving Assessment test with Worcestershire County Council at least every three years."

Instead licence holders will only have to undertake a driving assessment before they first become licensed or when a Licensing Sub-Committee resolves that an individual driver needs to undertake further assessment following receipt of relevant and verifiable complaints about the standard of their driving.

I believe this is an unjustifiable requirement that is time consuming and serves no clear purpose. Licensed drivers should only have to carry out the driving assessment test when initially applying for their licence.

I think there is no need to test a driver who does not have a medical condition and which is already in rules so.

I think Redditch drivers have good record for safe driving and I don't see any need to go for driving test after every three years when his driving is ok.

Any driver breaking the law must be made to do an assessment. New drivers should be made to do the test, I think a lot of them need to take lessons again.

Comments received from those answering NO to the main consultation question above:

I have been driving hackney carriage for 30 years and after so many years of experience I have no issue or complaint. I prefer to not participate with the assessment

I don't agree because test was done before already cost too much paying renew badge licence MOT

I do not agree with this proposal as I feel it is unfair on drivers like myself who have been performing this job with no driving convictions. I passed my driving test on 02/12/1974 and started my taxi profession in 1978 - present. I feel that drivers who have had driving convictions should have further driving assessment tests and not drivers like myself with a clean record.

Its unnecessary, especially when every driver has passed their practical driving assessment through DVSA which is a very thorough test set by the Government. I believe it is not really justified and does indeed serve very little purpose. To my knowledge no other Council in the whole of the UK undertakes this type of assessment, it is a waste of time for the Council and driver and also a waste of money

I would like to ask the Redditch Borough Council what practical purposes does this assessment have? Every taxi driver has passed their practical driving test set by the Government. The DVSA practical test is not easy by any means. Every taxi driver has the knowledge and skills required to carry out their job. This assessment is a complete waste of time and money (for both the Council and drivers) and insulting. I really don't see any point of it, in fact it seems very unfair and not justifiable.
