- 2. Security of OUR houses and the nearby business properties with unsociable hours 7 days a week!

I wish to object to the above mentioned application for the following reasons.

- 1. There is often an ongoing problem with parking as some local residents use this area and also the staff at the local businesses use it as well as HGV drivers during their lay over times prior to or after doing local deliveries and also clients of the local Gym..
- 2. By introducing this quite unnecessary commodity into this area it will potentially invite even more unwelcome "visitors" to our area which is already a problem as we have frequently to deal with cars using the road as a race track at all hours of the night/morning. The estate is also used often as a meeting place for groups of people in cars for whatever unknown reason one can only imagine.
- 3. It will cause more anti-social littering in the area as this is already a big problem as there is only one litter bin anyway (which does get emptied periodically) and other litter is never collected if its not in the bin. We need at lest 2 more bins 1 for each lay-by area and regular litter patrols. Although this is maybe a separate issue I feel it needs to be mentioned that there are areas on the Royal Enfield that haven't been cleaned/maintained since before the Covid epidemic, so in fact the last five years.
- 4. The security of our homes and businesses will be at more at risk if this is allowed to go ahead and also 7 days a week why oh why is it necessary anyway when we have a similar food outlet a couple of hundred yards away and of course there are many, many other food outlets less than a mile away in the town which we are supposedly encouraged to support
- 5. This applicant clearly does not live in this area and therefore would not be affected by the problems caused by the granting of this application or the adverse problems caused to the inhabitants in this area.
- 6. A NOT ON MY DOORSTEP seems to be the attitude taken if this is allowed.
